**DETERMINE THE VALUE OF PROTESTS) RESOLUTION OF APPROVAL STANDS
RECEIVED AND NOT WITHDRAWN)
RELATED TO THE "MANNING AND)
COLORADO AVENUE REORGANIZATION")**

WHEREAS, these Conducting Authority proceedings concerning the approved "Manning and Colorado Avenue Reorganization" were duly and regularly conducted pursuant to Division 3 of Title 3 of the California Government Code, commencing with Section 56000; and

WHEREAS, said Reorganization included the annexation of 3.62 acres to the City of San Joaquin and detachment from the Kings River Conservation District and the James Irrigation District for territory located along the south side of Manning Avenue between Colorado and Placer Avenues, and for territory located along Colorado Avenue south of Manning Avenue, and further described in Exhibit "A", attached hereto and by this reference incorporated herein; and

WHEREAS, at its June 4, 2008 meeting, this Commission conditionally approved the "Colorado and Manning Avenue Reorganization" by adopting Resolution No. RO-08-7; and

WHEREAS, at the June 4, 2008 hearing, this Commission found that not all property owners had submitted a signed, written waiver of protest proceedings and directed the Executive Officer to set the matter for a protest hearing pursuant to Section 57002 of the Government Code; and

WHEREAS, the Executive Officer duly gave notice of the protest hearing in accordance with California Government Code Section 57025, and all other applicable sections of the California Government Code, said noticing being published in the local newspaper and mailed to all property owners in the affected territory; and

WHEREAS, all property owners in the affected territory were provided with written individual notification summarizing the approved reorganization, outlining the protest procedures and rules for protesting an uninhabited annexation, and an Official LAFCo Protest Form; and

WHEREAS, this Commission on August 13, held a duly noticed Protest Hearing, as provided for in Section 57000 et seq. of the California Government Code for the purpose of hearing objections and protests to the approved reorganization, to receive written "official" protests, and to allow for the withdrawal of any written protests filed with this Commission prior to or at said hearing, if any; and

Section #4. All proceedings of this Commission concerning the proposed Reorganization have been duly carried out and completed, in conformity with all applicable laws.



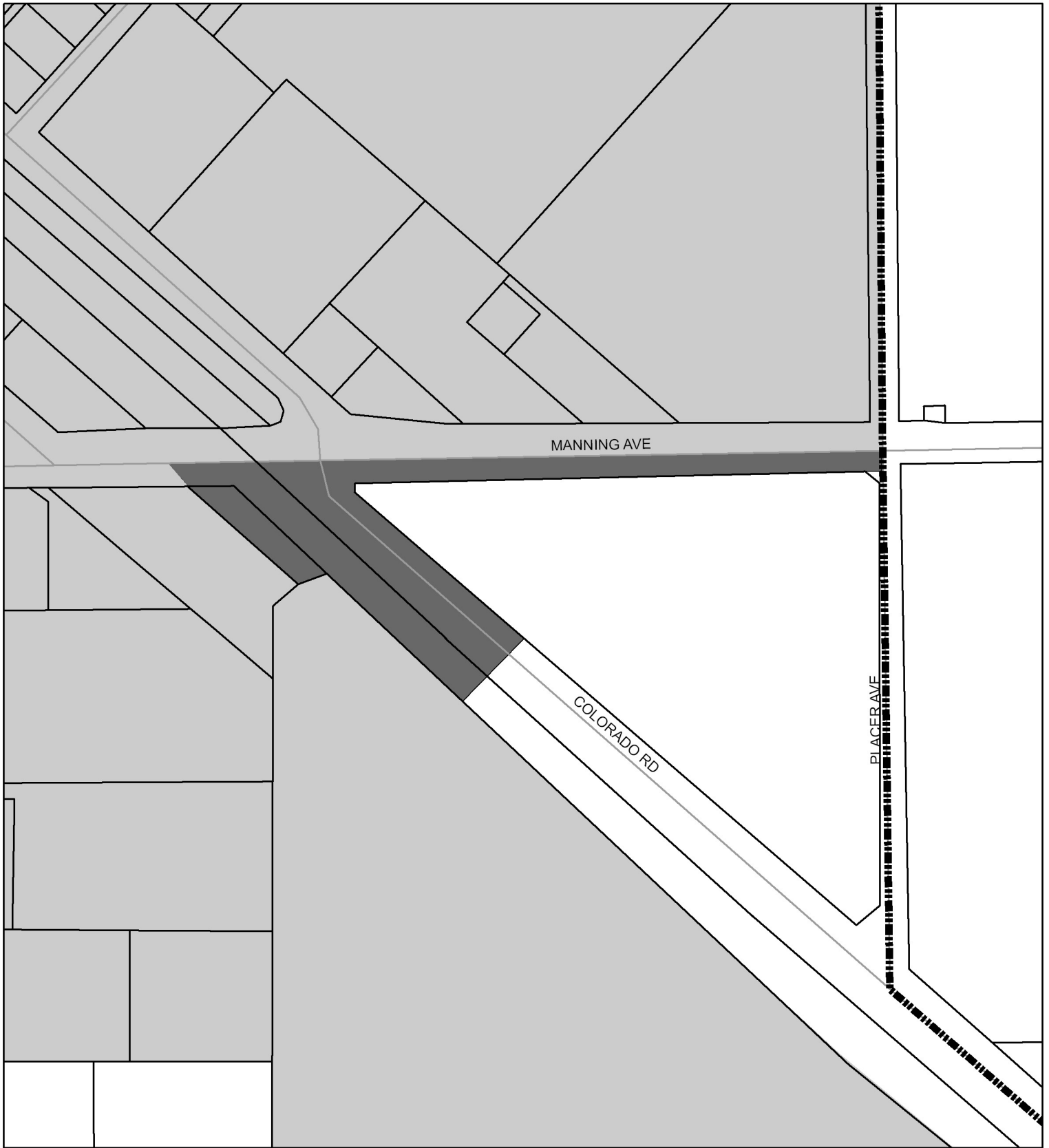
