Fresno LAFCo cordially invites you to attend the 2009 CALAFCo Conference scheduled for October 28th through 30th. The Conference setting is at the beautiful Tenaya Lodge near Yosemite National Park and is to take place during the foliage season when the leaves of the Sierra Nevada turn their bright colors.

Our Conference will begin with a Mobile Workshop in Fresno County that “spotlights” the San Joaquin River Parkway—a regional public conservation effort aimed at restoring a 23-mile segment of the San Joaquin River by placing 6,000 acres of land into public trust. Come join us for a morning along the River to learn how this effort had its beginning and what the future holds for this unique California natural resource.

This year's Conference theme is “A New Deal or a House of Cards: LAFCo's Role in Preparing for California's Recovery and the Future”. The Conference Program Committee has purposely planned its sessions and discussions around this topic which we believe will be of great interest to our local governments. This year's Conference even invites discussion of LAFCo's role in dealing with Native American Tribes, their Casinos, infrastructure needs, and relationships with LAFCos.

It is a great way in which to network and meet new friends. We understand that John Muir will also be able to visit us and will appear as our “guest speaker” on Thursday at noon. Parking Free

Travel Tenaya Lodge is located 12 miles north of Oakhurst on State Highway 41. Driving times are approximately 3½ hours from the Bay area; 4½ hours from Los Angeles; 3 hours from Sacramento; and 1½ hours from Fresno. Tenaya is located two miles south of the entrance to Yosemite National Park; a park entrance fee is **not** required unless you choose to drive through the park.



Airline service is available to Fresno International Airport (www.fresno.gov/DiscoverFresno/Airports) by a number of carriers. Amtrak San Joaquins (www.amtrak.com) provides rail service to Fresno.

Yosemite National Park Entrance fee is \$20/car and is valid for seven days. An annual permit to the park is available for \$40 (www.nps.gov/yose).

Tips to Help Get More Out of a CALAFCO Conference

Before the Conference

- ◆ Make a public announcement at a commission meeting that representatives from your LAFCo will attend. Indicate who will attend, the purpose and value of their participation, and the approximate budgeted cost.
- ◆ Review the conference program and determine which sessions, discussions and activities will directly benefit you and your LAFCo.
- ◆ Explain the benefits and return on investment for conference participation. LAFCo is a significant and complex responsibility. Training commissioners and staff to be effective leaders and decision makers is an educational investment that benefits the entire community.
- ◆ Designate an attending representative to prepare a written or verbal summary report to the entire commission following the conference.

During the Conference

- ◆ List specific questions you want answered during the sessions. If the speakers don't satisfy your needs, ask questions during or after the presentation. Take notes on each session.
- ◆ Collect material to share with commissioners who did not attend, including handout materials that have relevance to your LAFCo.
- ◆ Get acquainted and talk informally with other attendees during breaks, receptions, and other social events. You can gain a great deal by networking with colleagues from LAFCos confronting the same challenges that you face.

After the Conference

- ◆ At a commission meeting, share the highlights of the conference and your own observations and impressions. If you discovered that your LAFCo is more successful or advanced than others in a given area or activity, point this out and compliment the staff and commission.
- ◆ Be available for response to media inquiries, interview requests, and other matters relating to the conference. Be prepared, informed, and direct in your response.
- ◆ Be positive and well-informed about the conference programming and its importance to the LAFCo. To be effective, commissioners and staff must have access to the best and most current information if they are to serve the community effectively.

CANCELLATION & REGISTRATION REFUND POLICY

1. Registrations are considered complete upon receipt of fees.
2. Cancellation requests made in writing and received by 5 October 2009 receive a 100% refund less \$20 handling fee.
3. Cancellation requests made in writing and received after 5 October 2009 but prior to 16 October 2009 may carryover for a period of one year one registration credit in the amount paid, less a \$20 handling fee, to apply to a future CALAFCO event.
