WHEREAS, this Commission on March 11, 2009 did approve the City of Fresno's "Belmont-Sunnyside No. 3 Reorganization (Island Annexation)" to annex 94 acres to the City of Fresno and detach from the Fresno County Fire Protection District, the Kings River Conservation District, and County Service Area No. 7 for territory generally located at the southwest corner of E. Belmont and N. Sunnyside Avenues, said territory being described within Exhibit "A", attached hereto and by this reference incorporated herein; and

WHEREAS, on March 11, 2009, the Commission approved the "Belmont-Sunnyside No. 3 Reorganization (Island Annexation)" with required findings and conditions; and

WHEREAS, the Commission received a request for reconsideration of such approval from the Easterby Kings Canyon Homeowners Association, said request being placed for hearing on the May 13, 2009 hearing; and

WHEREAS, notice of the hearing of said application was duly given by mail, posting, and newspaper publication as required by State law; and

WHEREAS, the Executive Officer presented his report addressing the sole issue of reconsideration and the Commission entertained public testimony; and

WHEREAS, the Commission after review and deliberation of the reconsideration request determined that there existed new evidence that was not available during the March 11, 2009, public hearing that served as justification for granting the reconsideration request and, therefore, approved said request; and

WHEREAS, at the May 13, 2009, hearing, the Executive Officer also presented a reconsideration report along with a letter from the City of Fresno requesting the item be continued to the June 10, 2009, hearing, to allow the City time to thoroughly research and consider the issues raised in the reconsideration request.

NOW, THEREFORE, BE IT RESOLVED that the request for continuance is granted, said hearing to be at the hour of 1:30 p.m. on the 10th day of June, 2009.


