SUBJECT: Consider Approval – Calendar Year 2009 LAFCo Hearing Schedule.

Section 501 of the *LAFCo Policies, Standards, and Procedures Manual* requires that the Commission adopt a schedule of regular meetings for the forthcoming calendar year at such time as sufficient information is available to do so. The adopted schedule is to include the time, date, and location of the meetings. It should also be noted that “Special Meetings” may also be called at any time by the Chairman of the Commission by serving notice of the time, place, and purpose of the meeting upon each member of the Commission.

Similar with past practice, regular monthly meetings are proposed to take place on Wednesday afternoons and all meetings are generally placed four to five weeks apart. The time and location of the meetings is shown on the proposed schedule as required by the Brown Act. Staff has coordinated its scheduling activities with the Clerk to the Board of Supervisors to assure that there are no conflicts with other proposed public meetings.
