SUBJECT: Consider Approval: City of Selma "DeWolf-Floral-Fahrney Reorganization," consisting of the annexation of 35.88 acres to the City of Selma and the Selma-Kingsburg-Fowler County Sanitation District and detachment from the Fresno County Fire Protection District, the Kings River Conservation District, and the Consolidated Irrigation District for territory located east of DeWolf Avenue, north of Floral Avenue, and west of SR 99 (LAFCo File No. RO-16-4).

Applicant: Bryant Hemby, Planner, City of Selma

Land Owners/Parties of Real Interest (100% consent): City of Selma, Selma-Kingsburg-Fowler County Sanitation District, Gerald Fahrney & Donald Fahrney

(This proposed reorganization has been placed on the consent agenda because the territory is uninhabited and all property owners have consented in writing to the annexation.)

RECOMMENDATION: Approve By Taking the Following Actions:

1. Acting as Responsible Agency pursuant to California Environmental Quality Act (CEQA) Guidelines, find that prior to approving the proposed annexation, the environmental effects of the Proposal as shown in the CEQA documents prepared, adopted, and submitted by the Lead Agency, were reviewed and considered, and determine these documents to be adequate pursuant to CEQA Guidelines Section 15096.
2. Find that the proposed reorganization is consistent with LAFCo Policies, Standards, and Procedures and the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (CKH).
3. Find pursuant to CKH and information in the record that:
 - A. The territory is uninhabited; and
 - B. All landowners and affected agencies have consented to the reorganization.
4. Assign the distinctive short form designation "DeWolf-Floral-Fahrney Reorganization" and approve the annexations and detachments subject to the following conditions of approval:
 - A. Required fees shall be paid to the Selma-Kingsburg-Fowler County Sanitation District in accordance with District regulations. The City of Selma shall submit satisfactory verification to the Executive Officer that said fees have been paid prior to the completion of the reorganization.

- B. Pursuant to Fresno LAFCo policy 103-05, the Executive Officer shall record the approved application if all conditions have been satisfied and once he or she has determined that the facts pertaining to the application during the time of recording are materially similar to those facts considered by the Commission when the application was approved. Facts, as used in the proceeding sentence, are defined to include, but are not limited to, whether or not the proposed project is materially similar to the project described in any application before the Commission.
5. Waive further Conducting Authority Proceedings and order the reorganization subject to the requirements of CKH and the 30-day reconsideration period.

Executive Summary

On May 2, 2016, the City of Selma initiated this reorganization with the adoption of Resolution No. 2016-23R, requesting that the Commission begin proceedings for the "DeWolf-Floral-Fahrney Reorganization" to annex 35.88 acres to the City of Selma and the Selma-Kingsburg-Fowler County Sanitation District and detach from the Fresno County Fire Protection District, the Kings River Conservation District, and the Consolidated Irrigation District.

The Fresno County CAO determined that the proposal is consistent with the Standards of Annexation contained within the City/County Memorandum of Understanding.

The City of Selma and the Fresno County Fire Protection District have a fire transition agreement in place as required by Commission policy section 102-04.

Proposal

The Proposal is within the City of Selma's sphere of influence, west of and contiguous to the city limits (Exhibits A and B). The proposed development conforms to the City's General Plan, which designates the subject territory for regional commercial land uses. The Proposal is currently zoned County AE-20 (Agriculture Exclusive) and has been rezoned to C-R (Regional Commercial).

The Proposal consists of the annexation of 35.88 acres to the City of Selma and the Selma-Kingsburg-Fowler County Sanitation District and detachment from the Fresno County Fire Protection District, the Kings River Conservation District, and the Consolidated Irrigation District for territory located north of east of DeWolf Avenue, north of Floral Avenue, and west of SR 99.

Ability of the City to Serve Water to the Subject Territory

Potable water will be provided to the territory by the California Water Company, a private for-profit water service in accordance with the rules and regulations of the California Public Utilities Commission. The company has the ability to serve the territory, as outlined in the Urban Water Management Plan for the Selma District, which was prepared by the California Water Service Company in December, 2010, which is currently being updated.

Relationship to Regional Housing Goals and Policies

The subject territory will be developed for commercial purposes consistent with the Selma General Plan and the recently-adopted Housing Element update and will not contribute any housing.

Environmental Determination

The City of Selma as "lead agency" conducted an initial study and on May 2, 2016, adopted a Mitigated Negative Declaration. (See Environmental Documents on LAFCo's website at www.fresnolafco.org.)

As Responsible Agency, the Commission is required to review and consider the City's environmental documents prior to taking its action. If the Commission determines that these documents are adequate, pursuant to CEQA, it may make the required findings provided under "Recommendations" above.

2. **Proposed Development** - The territory proposed for annexation will be developed with a 102-room hotel, auto dealership, two anchor stores, and general retail, all comprising approximately 361,000 sq. ft. of commercial uses.

3. **Surrounding Territory** – Vineyard to the west; drainage and recharge pond to the north; commercial land to the east; and farm land to the south.

4. **Consistency with Adopted Sphere of Influence (SOI)** - The subject territory is within the LAFCo-approved Sphere of Influence for Selma.

5. **Consistency with City and County General Plans** - The Proposal will be consistent with the City of Selma's General Plan once annexed. The Proposal furthers the County's General Plan policies of directing growth to existing cities where infrastructure and a full range of municipal services are available to serve urban development.

8. **Costs and Other Changes Affecting Residents or Landowners** - The landowner will be required to pay the City of Selma's development fees for police and fire services and circulation impacts caused by the project.

9. **Consistency with LAFCo Policies, Standards and Procedures**

- All properties within the Proposal have been rezoned to the Selma C-R Zone District and the proposed uses conform to this rezoning.
- The County has determined that the Proposal is consistent with the Memorandum of Understanding (Master Tax Sharing Agreement) and the Standards for Annexation between the City of Selma and County of Fresno (see letter from Mr. Jean Rousseau, Fresno County CAO dated May 13, 2016 - Correspondence and Comments). The County recommended that "the City of Selma include the full width of right-of-way of Floral Avenue in this reorganization.

In accordance with Article II, Section 2.4 of the Amended and Restated Memorandum of Understanding (MOU) between the City of Selma and the County of Fresno, the County has reviewed the proposed annexation described in the letter from the City received on April 1, 2016 and supplemental information subsequently provided.

We have determined that the proposed annexation by the City of Selma is consistent with the Alternate Standard for Annexation contained in Section 2.4 of Article II of the MOU. Dear Mr. Hemby,

The Selma-Kingsburg-Fowler County Sanitation District has received a letter dated April 14, 2016 from the City of Selma requesting that the District re-issue a will-serve letter for the subject project.

The District will serve the above-referenced development project estimated at two hundred eighty nine (289) Equivalent Single Family Residences (ESFR's). The estimated ESFR's are based on preliminary conceptual information provided by you. The actual ESFR's would be determined as the project may progress. This will-serve letter has a time limit of 2½ years from the date of this letter, or expiration of tentative map, whichever comes later. This will-serve letter is good for the life of a final map.

Sewer Infrastructure Plans - All information provided by the District to date has been provided as a preliminary response to describe District planning documents, policies or existing infrastructure. Discussions, information and this letter shall not be considered to be acceptance of any sewer infrastructure plans. Any interested party must submit to the District a detailed set of sewer infrastructure plans or floor and plumbing plans for all buildings. With regard to a detailed set of sewer infrastructure plans or floor and plumbing plans, District staff will review submitted plans, but plans will not be signed off until the annexation has been completed by LAFCo or the property is within the City boundaries.

Plan check and inspection fees shall be paid at the time of submittal of plans to the District. The plan check process is not complete until the District has signed off on the plans. All sewer improvements required for a project are identified at completion of the plan check process.

Design Standards and Master Plan – On site and off site sewer system facilities must be designed and constructed in accordance with the District's Collection System Construction Standards, the District's Sewer System Master Plan and other requirements as may be specified by the District. The Standards and the Master Plan may be viewed on the District's website at www.skfcsd.org.

Fees and Connection Permit - Applicable District annexation fees must be paid for the entire project prior to completion of annexation or, if the fees have been deferred, at the time the District issues the project's first sewer connection permit. District capacity charges must be paid at the time the District issues a sewer connection permit. District capacity charges are subject to change and must be paid at the rates in effect at the time the sewer connection permit is issued by the District. Sewer system improvements must be constructed, tested and approved by the District prior to the issuance of a sewer connection permit. You must contact the City in which the project is located in order to pay the separate City sewer connection fee and to determine if there are applicable reimbursement fees to be paid.

Will-Serve Letters Policy - The District's 6-14-07 Will-Serve Letter Policy states "Staff shall issue will-serve letters, with no up-front fee or deposit, at the request or concurrence of a City/County, with the will-serve letters having a time limit of 2 1/2 years, or expiration of tentative map, whichever comes later, with the will-serve letter being good for the life of the final map."

New City Sewer Collection System Infrastructure Reimbursement - The District does not participate financially in the construction of new City sewer collection system infrastructure. Persons interested in possible reimbursement for such construction must make arrangements in writing with the City in which the infrastructure is constructed and such written arrangements must be made prior to the District signing off on plans.

New District Interceptor System Infrastructure Reimbursement - With regard to the construction of new District interceptor system infrastructure, persons interested in possible reimbursement must obtain agreements or District determinations, each in writing, from the District prior to the District signing off on plans.

Existing City or District Sewer System Infrastructure Reimbursement - With regard to the refurbishment or replacement of existing City or District sewer system infrastructure, persons interested in possible District financial participation must obtain agreements or District determinations, each in writing, from the District

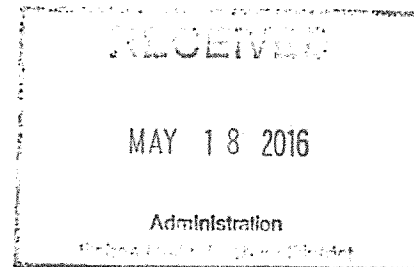
