**A RESOLUTION OF THE FRESNO LOCAL AGENCY FORMATION COMMISSION  
CONTINUING THE HEARING ON THE MUNICIPAL SERVICE REVIEW, SPHERE OF  
INFLUENCE UPDATE, AND ANNEXATION RELATED TO COUNTY SERVICE AREA 32 TO  
APRIL 13, 2022**

**WHEREAS**, pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH"), the Fresno Local Agency Formation Commission is required to review and update, as necessary, spheres of influence ("SOI") of local agencies not less than once every five years; and

**WHEREAS**, on September 23, 2021, the County Service Area 32 ("CSA 32 or District") submitted an application (File No. USOI-206) and supporting materials to this Commission pursuant to Government Code section 56428 requesting LAFCo an expansion of the District SOI to add approximately 46 acres to accommodate an approximate 43 acres annexation (File No. AD-21-01); and

**WHEREAS**, CKH directs the Commission to conduct a Municipal Service Review ("MSR") no later than the time it considers an action to either determine, amend, or update a SOI for a local agency; and

**WHEREAS**, the Executive Officer prepared an MSR for CSA 32 in response to the request for a SOI update, published the MSR on the Commission's website, and provided a mailed 21-day public notice to all affected local agencies; and

**WHEREAS**, notice of the Commission hearing for the proposed District SOI update was duly given in a publication of general circulation as required by CKH, at the time, in the form and manner provided by law; and

**WHEREAS**, the Executive Officer reviewed said application and prepared a staff report to the Commission, including a recommendation for approval, said report having been mailed to each affected local agency within the affected territory and interested individuals pursuant to Government Code section 56428(c); and

**WHEREAS**, at the duly noticed public meeting held on March 9, 2022, the Commission motioned to continue the proposed CSA 32 MSR and SOI and annexation to a date certain of April 13, 2022.

**NOW, THEREFORE, BE IT RESOLVED that the Fresno Local Agency Formation Commission does hereby DETERMINE AND ORDER, as follows:**

1. Continue the hearing for County Service Area 32 Municipal Service Review and sphere of influence update (LAFCo File No. USOI-206) to April 13, 2022.

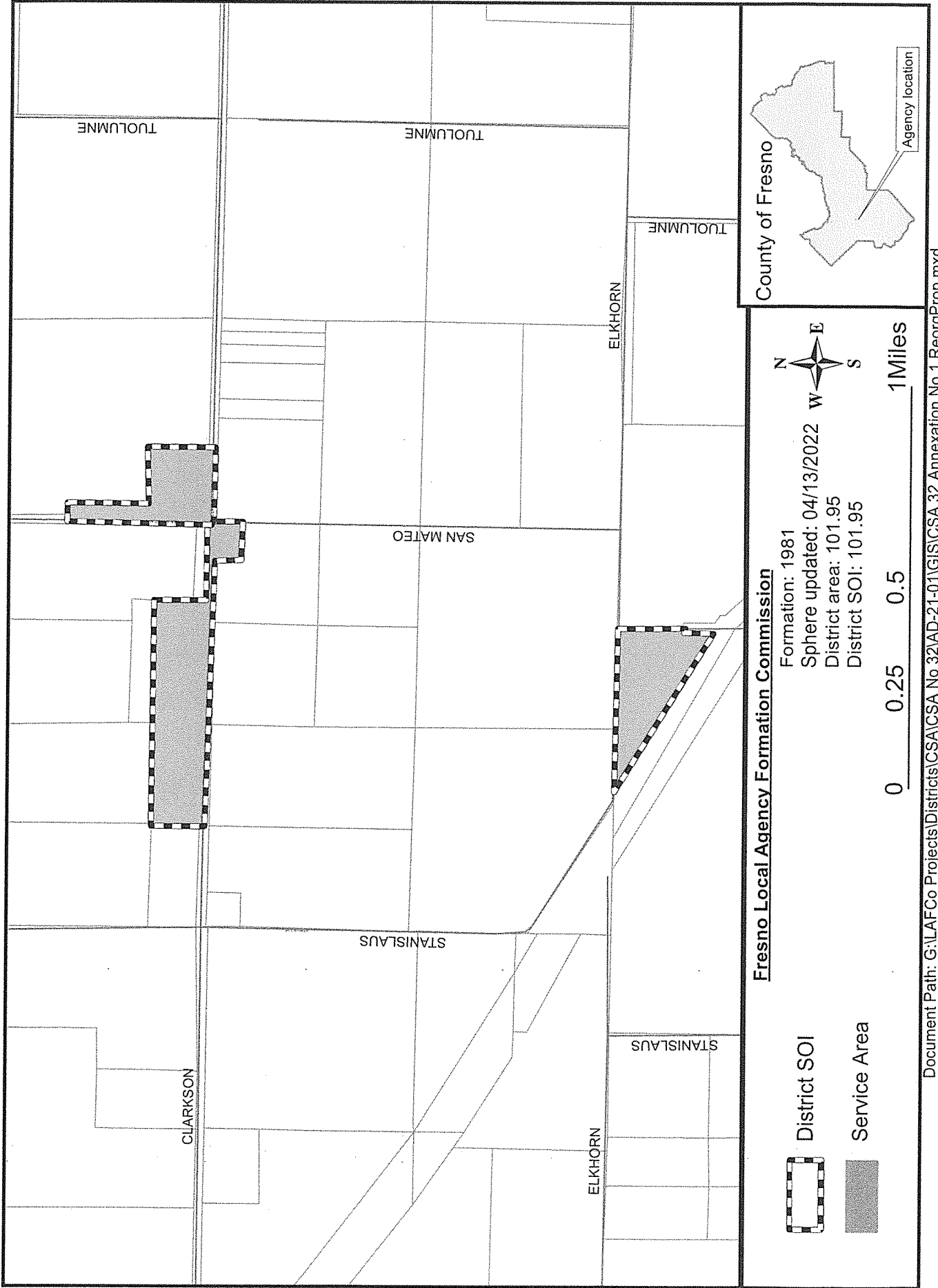
