WHEREAS, pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Section 56425 et. seq.) the Fresno Local Agency Formation Commission is required to review and update, as necessary, Spheres of Influence of local agencies not less than once every five years; and

WHEREAS, Government Code Section 56430 directs the Commission to conduct a review of municipal services not later than the time it considers an action to establish or update a Sphere of Influence (SOI); and

WHEREAS, the Commission prepared a Municipal Service Review for the Raisin City Water District; and

WHEREAS, the Municipal Service Review was set for hearing on the 3rd day of June, 2015, at the hour of 1:30 p.m.; and

WHEREAS, notice of this Commission's hearing of said Municipal Service Review was duly given in a publication of general circulation as required by the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 and State law, and at the time and in the form and manner provided by law; and

WHEREAS, at the June 3, 2015 hearing, the Executive Officer reported that the Raisin City Water District acknowledged there were some issues and requested additional time to address the issues that were identified in the draft municipal service review; and

NOW, THEREFORE, BE IT RESOLVED that the Local Agency Formation Commission of the County of Fresno does HEREBY continue the hearing on the Municipal Service Review and Sphere of Influence Update for the Raisin City Water District to October 14, 2015.


