Subject: MSR 21-3 / USOI-201 – Recommendations and Follow-up Actions

Fresno LAFCo would like to extend its appreciation to the Firebaugh Resource Conservation District ("Firebaugh RCD" or "District") for its active participation with the Commission's Municipal Service Review Program.

On May 12, 2021, Fresno LAFCo approved the Firebaugh RCD Municipal Service Review ("MSR") and Sphere of Influence ("SOI") update prepared for the District in compliance with Government Code §56430 and §56425. At this hearing the Commission made various recommendations that require timely action by the District.

Enclosed is a copy of the Commission's resolution for its adoption of the District's MSR and SOI update. The Commission's recommendations to the District are listed below:

- A. That the District reinstate an annual budget program that identifies the District's revenues and expenditures for the upcoming year.
- B. That the District Annually file a copy of the District's adopted budget for the upcoming fiscal year with the Fresno County Assessor Controller Treasurer Tax Collector's Office, Special Accounting Division, pursuant to Government Code section 53901.
- C. That the District Annually prepare audited financial statements for all District financial transactions in accordance with generally accepted accounting principles for the preceding fiscal year; and, furnish a copy to the State Controller, pursuant to Government Code section 53891.
- D. That the District Annually file a copy of the District's audited financial statements within 12 months of the closed fiscal year with the Fresno County Assessor

Controller – Treasurer Tax Collector's Office, Financial Reporting & Audits Division, pursuant to Government Code section 26909.

- E. That the District continues its effort to fill the two vacant director seats with qualified individuals, pursuant to Public Resource Code section 9301.
- F. That the District continue its commitment to reinstate services, build new partnerships, and secure a source of revenue to fund its adopted Work Plan.
- G. That the District report its actions in compliance with these recommendations in writing to the Fresno LAFCo no later than **May 12, 2022.**

Please be advised that failure to perform these tasks or to provide Fresno LAFCo with a record of their timely completion may result in the Commission's reconsideration of the District's designated SOI.

RESOLUTION NO. MSR 21-3 / USOI-201

A RESOLUTION OF THE FRESNO LOCAL AGENCY FORMATION COMMISSION MAKING DETERMINATIONS AND ADOPTING A MUNICIPAL SERVICE REVIEW; MAKING DETERMINATIONS AND UPDATING THE SPHERE OF INFLUENCE FOR THE FIREBAUGH RESOURCE CONSERVATION DISTRICT

WHEREAS, pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH"), the Fresno Local Agency Formation Commission is required to review and update, as necessary, spheres of influence ("SOI") of local agencies not less than once every five years; and

WHEREAS, on August 20, 2019, the Tranquillity Resource Conservation District ("District") submitted an application (File No. USOI-194) and supporting materials to this Commission pursuant to Government Code section 56428 requesting LAFCo an expansion of the District SOI that would facilitate the planned, orderly, and efficient growth of the District; and

WHEREAS, the District's SOI update application No. USOI-194 triggered a simultaneous review of LAFCo's 2007 consolidated SOI of the five Resource Conservation Districts ("RCDs") in Fresno County's west side: Firebaugh RCD, James RCD, Panoche RCD, Poso RCD, Tranquillity RCD, and Westside RCD; and

WHEREAS, the objective of the 2007 consolidated SOI for the RCDs was to facilitate the eventual consolidation of Fresno County's westside RCDs; and

WHEREAS, the LAFCo's review of the 2007 consolidated SOI for the RCDs notes that it has not served its original objective as proposed by LAFCo; and

WHEREAS, CKH directs the Commission to conduct a Municipal Service Review ("MSR") no later than the time it considers an action to either determine, amend, or update a SOI for a local agency; and

WHEREAS, the Executive Officer prepared MSRs for Tranquillity RCD, Firebaugh RCD, James RCD, Panoche RCD, and Westside RCD, in response to Tranquillity RCD's request for a SOI update, published the MSRs on the Commission's website, and provided a mailed 21-day public notice to all affected local agencies within the affected territory; and

WHEREAS, notice of the Commission hearing for the District SOI update and update of the 2007 consolidated SOI for the RCDs was duly given in a publication of general circulation as required by CKH, at the time, in the form, and manner provided by law; and

WHEREAS, the Executive Officer reviewed said application and prepared a staff report to the Commission, including a recommendation for approval, said report having been mailed to each affected local agency within the affected territory and interested individuals pursuant to Government Code section 56428(c); and

WHEREAS, at the duly noticed public meeting, held on May 12, 2021, the Commission heard, discussed, and considered all relevant evidence, including but not limited to the MSRs determinations and recommendations, environmental review documents, and all testimony, correspondence, and attachments received during the public hearing process.

NOW, THEREFORE, BE IT RESOLVED that the Fresno Local Agency Formation Commission does hereby DETERMINE AND ORDER, as follows:

ACTION 1: MUNICIPAL SERVICE REVIEWS

A. Acting as Lead Agency pursuant to California Environmental Quality Act ("CEQA") Guidelines find that the MSRs prepared for: Tranquillity RCD, Firebaugh RCD, James RCD, Panoche RCD, and Westside RCD are Categorically Exempt from the provisions of CEQA under section 15306, "Information Collection."

- g. Direct the District to report its actions in writing to the Fresno LAFCo no later than May 12, 2022.
