WHEREAS, on May 12, 2020, the Commission held a public hearing to consider the final LAFCo budget and work plan for FY 2021-22, and at said hearing considered the Executive Officer's report, an addendum, recommendations, all relevant factors, and heard all interested persons wishing to speak on the matter.

NOW, THEREFORE, BE IT RESOLVED that the Fresno Local Agency Formation Commission does HEREBY DETERMINE AND ORDER as follows:

- 1. Adopt recommended final budget and work plan for FY 2021-22 as set forth in Attachment "A"; and
- 2. Amend LAFCo's salary resolution to reflect the change to the State's minimum hourly wage.
