RESOLUTION NO. MSR 21-01 / USOI-200

A RESOLUTION OF THE FRESNO LOCAL AGENCY FORMATION COMMISSION MAKING DETERMINATIONS AND ADOPTING A MUNICIPAL SERVICE REVIEW; MAKING DETERMINATIONS AND UPDATING THE SPHERE OF INFLUENCE FOR THE FRESNO MOSQUITO AND VECTOR CONTROL DISTRICT

WHEREAS, pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH"), the Fresno Local Agency Formation Commission is required to review and update, as necessary, spheres of influence ("SOI") of local agencies not less than once every five years; and,

WHEREAS, the Fresno Mosquito and Vector Control District ("District") submitted an application (File No. USOI-200) and supporting materials to this Commission pursuant to Government Code section 56428 requesting LAFCo an expansion of the District SOI to add 365 acres that would facilitate the planned, orderly, and efficient growth of the District (Attachment A); and,

WHEREAS, in a joint effort, the District and the Madera Mosquito and Vector Control District ("Madera MVCD") request Fresno LAFCo to simultaneously update their SOIs in anticipation of a boundary reorganization that would memorialize their respective service areas; and,

WHEREAS, the 365-acre affected territory is identified in the County of Madera and within the Madera MVCD; and,

WHEREAS, the District's SOI update application No. USOI-200 triggers a simultaneous reduction in Madera MVCD's SOI as a precursor to detach the affected territory from Madera MVCD; and,

WHEREAS, on December 9, 2020, the Madera County Local Agency Formation Commission granted approval to vest exclusive jurisdiction to Fresno LAFCo to process Fresno LAFCo application No. USOI-200 consistent to the requirements in section 56338 of CKH; and,

WHEREAS, CKH directs the Commission to conduct a Municipal Service Review ("MSR") no later than the time it considers an action to either determine, amend, or update a SOI for a local agency; and,

WHEREAS, the Executive Officer prepared a MSR in response to the District's request for a SOI update, published the MSR on the Commission's website, and provided a mailed 21-day public notice to all affected local agencies and landowners within the affected territory; and,

WHEREAS, notice of the Commission hearing for the District SOI update was duly given in a publication of general circulation as required by CKH, at the time, in the form, and manner provided by law; and,

WHEREAS, the Executive Officer reviewed said application and prepared a staff report to the Commission, including a recommendation for approval, said report having been mailed to each

affected local agency within the affected territory and interested individuals pursuant to Government Code section 56428(c); and

WHEREAS, at the duly noticed public meeting, held on April 14, 2021, the Commission heard, discussed, and considered all relevant evidence, including but not limited to the MSR determinations and recommendations, environmental review documentation, and all testimony, correspondence, and attachments received during the public hearing process.

NOW, THEREFORE, BE IT RESOLVED that the Fresno Local Agency Formation Commission does hereby DETERMINE AND ORDER, as follows:

ACTION 1: MUNICIPAL SERVICE REVIEW

A. Acting as Lead Agency pursuant to California Environmental Quality Act ("CEQA") Guidelines find that the MSR prepared for the District is Categorically Exempt from the provisions of CEQA under section 15306, "Information Collection."


