SUBJECT: LAFCo Support of "One Voice D.C." Fresno COG's Regional Advocacy

RECOMMENDATION:

If the Commission intends to participate in the 2016 "One Voice D.C." trip, staff recommends the following actions:

1. Approve the expenditure of \$2,525 from the Contingency Fund (account # 51170) for the purposes described in this report;
2. Find that the circumstances exist that support an increase in the specified maximum reimbursement rate for lodging and per diem; and
3. Identify a Commission member to represent the Fresno LAFCo on the 2016 "One Voice D.C." trip; and
4. Assign responsibility to that member to complete the attached registration form (Attachment "A") and convey it to the Fresno COG "One Voice D.C." project manager in a timely manner.

Background

At its January 13, 2016 meeting, the Commission discussed funding a member of LAFCo to represent the Commission on the 2016 "One Voice D.C." trip. Because the item was raised during Commission comments and was not agendaized for action, staff was directed to bring an action item to the Commission at its February meeting.

"One Voice D.C." is Fresno COG's regional advocacy effort that assembles a public-private delegation to visit Congressional and federal departmental representatives in Washington, D. C. The goal is to educate them about Fresno County's regional priorities and needs as they work to develop policy on transportation reauthorization, water, and economic development. An example of the COG's regional priorities is attached as Attachment "B."

The Annual Fresno COG "One Voice D.C." trip for elected officials, business leaders and staff is scheduled for April 16-21, 2016.

Fiscal Effect

The fiscal impact of a Commissioner's participation in the "One Voice D.C." trip is estimated as:

Airline ticket/Hotel	\$2,000 (Fresno COG estimate).
Fresno COG Registration	\$150 (Per COG website)
Per diem	\$375 (Per LAFCo Travel Reimbursement Policy of \$75.00/day x 5 days)
Total	\$2,525

Fresno LAFCo Financial and Accounting Procedures (FAP) travel reimbursement policies limit lodging to \$150 per night but permit this reimbursement rate to be exceeded under certain circumstances. Per the FAP, per diem is limited to \$60 per day but may be increased to \$75 when traveling to high cost cities as defined by the Internal Revenue Service.

Washington D.C. is identified as a High-cost locality in the 2014-2015 Special Per Diem Rates.¹

Consistency With LAFCo Policies, Standards, And Procedures

Though regional advocacy is not directly a LAFCo objective, a LAFCo representative on the "One Voice D.C." trip generally promotes the Commission's goals for orderly, logical, and efficient service delivery. If a LAFCo representative on the trip is supported, the Commission should schedule a time during its May, 2016, meeting to debrief the Commissioner, learn from his experience, and debate whether to amend LAFCo policies and/or its annual budget to support further participation in COG's regional advocacy efforts.

Subject: Intent to Travel – Fresno “One Voice” Trip – April 16-21, 2016

We are in the process of planning our One Voice Trip to Washington, DC scheduled for April 16-21, 2016. If you have budgeted to participate in this trip, please let us know. We are currently holding 25 hotel rooms at the Hyatt Regency Washington on Capitol Hill 400 New Jersey Ave NW, Washington, DC – (202) 737-1234 (with 4 spots committed to COG staff and Chair) at the price of \$299.00 per night.

The cost for hotel accommodations and airline tickets for the 2015 One Voice Trip was approximately \$1,850. Using last year's figure as a rough estimate, we anticipate that this year's cost may increase slightly to \$2000 (hotel & flight; this does not include the price of meals).

Cost:

A \$150 registration fee is required for each participant attending the 2016 One Voice trip. The registration fee must be paid by February 26, 2016. This fee includes your materials and the closing dinner on Wednesday evening. Given the close proximity to the Capitol Building, Metro Passes will not be purchased this year. However, if you would like one, staff can arrange one be made available to you. You will be billed for any remaining charges over \$150 that Fresno COG may incur on your behalf. Fresno COG is not responsible for your hotel charges, alcohol purchases or other room incidentals. Any additional payments owed to Fresno COG must be remitted no later than May 13, 2016. Registration fees apply to each One Voice participant only. Spouses and/or guests of One Voice participants must pay for themselves prior to or at planned events. Spouses and/or guests must also complete and sign a commitment form.

Based on feedback received from prior One Voice surveys, you will be responsible for obtaining breakfast on your own. Morning briefings will be held in either the hotel restaurant; a hotel conference room, or at another location. Everyone must attend the morning briefings and must be ready to leave the hotel at the designated time allowing time to travel to the meeting locations.

If you register to participate in a planned dinner where prior reservations are required and you cancel after the cutoff deadline date for the reservation, you will be charged for the dinner.

"One Voice" advocacy effort is to seek federal support or funding for projects of broad community-wide benefit and regional significance within Fresno County. In order to accomplish this goal, a delegation of elected officials, public administrators and regional stakeholders from the public and private sectors join together to visit Washington D.C. and Sacramento on an annual basis. On the trip, the delegation meets with Congressional, legislative, and departmental representatives to advocate for the regionally significant issues that have been agreed upon during the COG selection process.

No delegate or agency will advocate separately on issues, other than those agreed upon by the Fresno Council Policy Board, during the same time period as the "One Voice" advocacy effort in Washington D.C. using the "One Voice" name, or at any other time, while using the "One Voice" name. This does not, however, preclude you from extending your stay in Washington D.C., or from bringing additional staff or representatives from your company or agency to Washington D.C. or Sacramento during the same time period as the scheduled One Voice trips. However, those additional staff members or representatives may not use the "One Voice" name during their additional activities.

Expand Drip Irrigation Funding Opportunities to Tenants	<p>During the course of the USDA-grant funded Valley Grow Project, one glaring challenge for many minority and disadvantaged farmers has become apparent: Those who rent the land they sow do not qualify for the USDA's Environmental Quality Incentive Program (EQIP) funding for drip irrigation. Because they do not own the relatively small pieces of land they cultivate, minority and disadvantaged farmers typically utilize temporary irrigation "tape" to water their crops rather than investing in more costly and permanent drip irrigation systems. For this reason, many minority and disadvantaged farmers do not qualify for the USDA's EQIP funding for drip irrigation.
