SUBJECT: **Consider Approval: "Laguna Irrigation District Annexation."** A proposed annexation of approximately 16,665 acres to the Laguna Irrigation District for territory generally bounded by Conejo Avenue to the north between State Route 43 and Sunnyside Avenue, and the Community of Laton to the south.

Applicant: Laguna Irrigation District.

Landowners/Parties of Real Interest: Laguna Irrigation District (See Attachment C)

RECOMMENDATION: Approve by Taking the Following Actions:

Action 1:

- A. Acting as Responsible Agency pursuant to California Environmental Quality Act ("CEQA") Guidelines, find that prior to approving the proposed annexation, the environmental effects of the Proposal as shown in the CEQA documents prepared, adopted, and submitted by the Lead Agency, were reviewed and considered, and determine these documents to be adequate pursuant to CEQA Guidelines section 15096.

Action 2:

- B. Find that the proposed annexation is consistent with LAFCo Policies and the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 ("CKH").
- C. Find pursuant to CKH and information in the record that:
 - a. The territory is inhabited; and
 - b. Not all landowners and registered voters have consented to the reorganization.
- D. Assign the distinctive short form designation "Laguna Irrigation District Annexation" and approve the annexation subject to the following conditions of approval:

- a. Pursuant to Fresno LAFCo Policy 103-05, the Executive Officer shall record the approved application if all conditions have been satisfied and once, he or she has determined that the facts pertaining to the application during the time of recording are materially similar to those facts considered by the Commission when the application was approved. Facts, as used in the proceeding sentence, is defined to include, but is not limited to, whether or not the proposed project is materially similar to the project described in any application before the Commission.
 - b. Submittal of corrected legal description and map.
- E. Find that pursuant to CKH the territory is inhabited and not all landowners have consented to the annexation.
- F. Find that the notice mailed on August 19, 2020, was given to all landowners and registered voters within the affected territory, as well as within 300 feet of the affected territory, disclosed that there is potential for the extension or continuation of any previously authorized charge, fee, assessment, or tax by the local agency in the affected territory, and that the Commission intends to waive protest proceedings pursuant to section 56663(a)(b)(c) unless written opposition is received before the conclusion of the Commission proceedings.
- G. Waive further Conducting Authority Proceedings and order the reorganization subject to the requirements of CKH.
- H. Find that no written opposition to the proposal was received prior to the conclusion of the hearing and approve the proposal subject to the requirements of the CKH, the 30-day reconsideration period, and compliance with all of the above conditions, and waive further conduction Authority Proceedings.

-Or-

- I. If written opposition to the proposal was received prior to the conclusion of the hearing, approve the proposal subject to the requirements of the CKH, the 30-day reconsideration period, and compliance with all of the above conditions, and direct staff to set a protest hearing pursuant to the requirements of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code section 57000 et seq.).

Executive Summary

On December 3, 2019, the Laguna Irrigation District initiated this annexation by adopting Resolution No. 19-08, requesting that the Commission begin proceedings for the "Laguna Irrigation District Annexation" to annex approximately 16,666 acres to the Laguna Irrigation District.

On July 8, 2020, Fresno LAFCo amended the Laguna Irrigation District sphere of influence to include the territory now requested for annexation.

Proposal/Land Use

- The Proposal consists of the annexation of approximately 16,666 acres.
- Information related to the Proposal's affected territory, land use, proposed development, special districts, surrounding areas, and existing/proposed services can be found on **Attachment A**.
- All affected territories are within the Laguna Irrigation District sphere of influence and are contiguous to the District's service area (**Attachment B**).
- 16,666 acres of the Proposal are currently zoned AE20 and AE40 (Exclusive Agricultural) no zone change is proposed as all affected territories are not proposed for development and currently developed to the density and intensity allowed by the County of Fresno.
- The territory is inhabited.

Revenue and Tax Code Section 99 (b)

On June 15, 2020 LAFCo issued a notice for jurisdictional change under revenue and tax code section 99 (b) to the Fresno County Assessor-Recorder and the Fresno County Auditor Controller/Treasure-Tax Collector. This notice is intended to notify the two departments of the jurisdictional change and upon receiving the notice these agencies are to commence calculations and negotiations to determine the amount of property tax revenues to be exchanged between the local agencies whose service area or service responsibility will be altered by the change.

On June 15, 2020, the general manager of the Laguna Irrigation District advised staff that the District did not want to proceed with the tax revenue exchange negotiations outline under revenue and tax code section 99(b) for the affected territory. The District does not collect property tax revenue but instead levies a use and benefit assessment on properties as permitted by the California Water Code. Staff concludes that because the affected special district does neither collect property tax revenue nor intends to there is no need for a property tax revenue exchange negotiation.

Sustainable Groundwater Management Act ("SGMA")

Former Governor Edmund G. Brown Jr. signed California's SGMA into law on September 16, 2014. This three-part legislation requires local agencies to develop groundwater sustainability plans that are compatible with their regional economic and environmental needs. SGMA creates a framework for sustainable local groundwater management for the first time in California's history.

SGMA requires local agencies to form Groundwater Sustainability Agencies ("GSA's") in local groundwater basins by June 2017 and requires the adoption of Groundwater Sustainability

Plans ("GSP's") for groundwater basins deemed high priority by year 2020. The Laguna Irrigation District is represented by the North Fork Kings GSA.

The affected territory is identified as a "white area," a Sustainable Groundwater Management Act ("SGMA") term meaning territory that is not within the boundaries of an existing water management agency, such as a city, irrigation or water district.

The affected territory is already part of the NFKGSA but is represented by the County of Fresno since it currently is outside any water management local agency. Likewise, the portion of the affected territory in Kings County is represented by the County of Kings for purposes of SGMA.

By annexing into the District, the affected territory would no longer be non-districted and would be represented by the District for SGMA and other purposes, landowners and registered voters would be eligible to serve on the District board, and landowners would be able to purchase water from the District, when available, for irrigation or groundwater recharge.

Environmental Determination

The Laguna Irrigation District, acting as "Lead Agency" under CEQA, filed a Class 19 categorical exemption for the Laguna Irrigation District Annexation filed with the office of the Fresno County Clerk on January 17, 2020 Document No. E202010000017 consistent with the requirements of CEQA.

As a "Responsible Agency" pursuant to CEQA Guidelines, the Commission is required to independently review and consider the environmental review for the proposed SOI update prior to reaching its decision. Therefore, the LAFCo, finds that it can be seen with certainty that the SOI update does not have the potential to result in a significant effect on the environment, and that the SOI update is not subject to CEQA pursuant to CEQA guidelines section 15061 (b)(3). Therefore, the proposal is exempt from environmental review.

Pursuant to CEQA Guidelines section 15096(i), if the Commission determines that these documents are adequate, A Notice of Determination will be prepared and filed with the County of Fresno Clerk's office in compliance with section 21152 of the Public Resources Code.

Costs and Other Changes Affecting Residents or Landowners - The annexed land would be subject to an annual assessment based on use ranging from \$0.00 per acres (if exempt) to \$24.50 per acre for irrigated lands, the same assessment levied on lands currently within the District.

Territory Boundaries - The boundaries of the proposed annexation are definite and certain, and the County Assessor has determined that the map and legal description are **not** adequate to file with the State Board of Equalization.

Registered Voter Data - The office of County of Fresno Elections reported that there are **219** registered voters in the affected territory.
