A proposed reorganization to annex approximately 140 acres to the City of Fresno and detach from the North Central Fire Protection District and the Kings River Conservation District for properties generally located west of North Polk Avenue, east of North Bryan Avenue, and on the north and south side of West Ashlan Avenue.
- 2. Dissolution of Zalda Reclamation District No. 801 pursuant to Senate Bill 938 (LAFCo File No. DOD-23-01)
- 3. Proposed Budget and Work Plan for Fiscal Year 2024-2025.

Regarding item 1, if you are a landowner or registered voter within the territory of the "Ashlan-Hayes Nos. 2, 3, and 4 Reorganization" as described above, you have protest rights and may file a written protest in opposition to the change of your property.

There is potential for extension or continuation of any previously authorized charge, fee, assessment, or tax by the local agencies.


